Behaviour Management Policy

Level 1 Infraction

Refusing to speak French, socializing in English, not participating in French activities.)

1st incident

Time out, removal from activity, possible loss of privileges, followed by meeting with camp counselors and/or camp director.

2nd incident

Time out. Camp director call home to update parents. Removal from activity, possible loss of privileges. Meeting with Camp director to discuss solutions.

3rd incident

Call home by camp director. Time out. Removal from activity, loss of privileges. Meeting with Camp director followed by removal from Camp¹.

¹ Any camper removed from camp will need to be picked up from camp immediately by their parent or guardian. They will not be permitted to finish the day. They will be removed from all activities and wait with the camp director for the parent or guardian's arrival. If you are unable to pick them up, a ride will be arranged with one of your emergency contacts.

Behavior Management Policy

Level 2 Infraction

Arguing, swearing, refusing to listen, being inappropriate, personal space, refusing to wear a mask where required, disrespecting staff.

1st Incident

Time out, removal from activity or possible loss of privileges, followed by a meeting with camp counselors and/or camp director.

2nd Incident

Phone call home to brainstorm solutions with parents. Time Out, removal from activity or loss of privileges, followed by debrief. Camper is to meet with camp director and staff.

3rd Incident

. Phone call home by camp director. Time out, removal from activity or loss of privileges, followed by a debrief. Likely removal from campⁱ.

¹ Any camper removed from camp will need to be picked up from camp immediately by their parent or guardian. They will not be permitted to finish the day. They will be removed from all activities and wait with the camp director for the parent or guardian's arrival. If you are unable to pick them up, a ride will be arranged with one of your emergency contacts.

Behaviour Management Policy

Level 3 Infraction

Violence (i.e.: hurting others, self or property); Stealing, bullyingⁱⁱ and threatening violence, physical confrontation.

1st Incident

Phone call home to parents/ Guardians. Meeting with camp director and counselors to discuss solutions. Consequence and behavioral contract must be signed or removal from campⁱ

2nd Incident

Removal from Campⁱ

ⁱ Any camper removed from camp will need to be picked up from camp immediately by their parent or guardian. They will not be permitted to finish the day. They will be removed from all activities and wait with the camp director for the parent or guardian's arrival. If you are unable to pick them up, a ride will be arranged with one of your emergency contacts.

ⁱⁱ CPF employs a zero-tolerance policy for bullying. If it is found that a child is bullying another, they will be asked to leave camp.
